President's Report

To All Members: You must make your September 19st luncheon reservations by September 11th as we will not accept any reservations after that date and there will be no walk-ins the day of the luncheon. The final count for the luncheon will be given to the Penn Harris on August 12th. As of the end of July, the total membership for the Central Penn Chapter is 8,405. This is 281 more than last year for our Chapter. The State membership total is 31,779 which is 1,734 more than last year. Since November 2013, PARSE has been increasing membership every year.

September is the month for nomination of officers for the next two years with the election in October. The nomination committee is comprised of: Sue Mitchell, Chairperson, Tom Hoffman and Darlene Cline. You need to give them your information prior to the opening of the September luncheon. We have three director positions that are up for election. You will need to give them your name, address, telephone numbers (both home and cell), and an e-mail address.
